**Title:** Appropriating \$385,000 from the Unappropriated Fund Balance of the Parking Fund; appropriating that amount to the Convention Center Garage account; authorizing a \$330,000 Owner’s Representative Services Amendment No. 2 to Contract No. 07-AR1902 with CBC Real Estate Group, LLC related to the programming, design and reconstruction of the Auditorium Plaza Garage and Barney Allis Plaza Event Space; authorizing contract amendments; approving the proposed program for the project; providing for a construction trades training program; declaring the intent of the City to reimburse itself from the bond proceeds for certain expenditures; and recognizing this ordinance as having an accelerated effective date.
