Appropriating \$750,743.00 in interest earnings from Tranche 1 of the American Rescue Plan Act from the Unappropriated Fund Balance of the American Rescue Plan Fund for the purpose of adding \$750,743.00 in available funding for the Rebuild KC program; and recognizing this ordinance as having an accelerated effective date.

WHEREAS, the City received \$194,776,376.00 in American Rescue Plan Act (ARPA) funds in two tranches; and

WHEREAS, tranche 1 ARPA funds were banked and invested pursuant to the City's codified Investment Policy and earned \$750,743.26 in interest income during Fiscal Year 2021-22; and

WHEREAS, interest earned on ARPA funds was recognized and collected and was added to the fund balance of the American Rescue Plan Fund during FY 2021-22; and

WHEREAS, staff recommends utilizing this interest income to fund neighborhood improvements through an additional appropriation to the Rebuild KC program; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the sum of \$750,743.00 is hereby appropriated from the Unappropriated Fund Balance of the American Rescue Plan Fund to the following account:

Rebuild KC

Section 2. That this ordinance is recognized as having an accelerated effective date within the provisions of Section 503(a)(3)(C) of the City Charter in that it appropriates money and shall take effect in accordance with that section.
