Approving and authorizing settlement of a lawsuit entitled Sarah Everhart v. City of Kansas City, Missouri, et al., Case No. 20BE-CC00026.

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the payment of the sum of \$160,000.00 for the settlement of claims asserted by Sarah Everhart in the lawsuit styled *Sarah Everhart v. City of Kansas City, Missouri, et al.*, Case No. 20BE-CC00026, as recommended by the City Attorney and the Risk Management Committee, is hereby approved.

Section 2. That the City Attorney is hereby authorized to pay the sum of \$160,000.00 in settlement of said claims asserted by Sarah Everhart in this lawsuit from funds previously appropriated in Account No. 23-7010-131545-B, Automobile Liability Fund.

I hereby certify that there is a balance, otherwise unencumbered, to the credit of the appropriation to which the foregoing expenditure is to be charged, and a cash balance, otherwise unencumbered, in the treasury, to the credit of the fund from which payment is to be made, each sufficient to meet the obligation hereby incurred.
