Sponsor: Director of Health Department

Authorizing the Director of Health to execute a \$343,666.00 contract amendment with the University of Missouri Kansas City for Violence Prevention Fund Evaluation Services from previously appropriated funds; and authorizing the Director of Health to extend the term of the contract to increase or decrease the total contract dollar amount upon need and appropriation with further Council approval.

WHEREAS, UMKC is the only local university that has an accredited criminology program, facilitated by the expertise of renowned researchers and relevant degree-seekers; and

WHEREAS, UMKC’s Department of Criminal Justice and Criminology, which includes Drs. Ken Novak and Marijana Kotlaja, has an established relationship with the Kansas City Police Department and the City of Kansas City, Missouri; NOW, THEREFORE;

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the Director of Health is authorized to execute a contract amendment with the

University of Missouri Kansas City, for \$343,666.00, for a total contract amount not to exceed \$1,655,150.00 for the provision of evaluation services for the Violence Prevention Fund. A copy of the contract amendment, in substantial form, is on file with the Director of Health.

Section 2. That the Director of Health is hereby authorized to expend a sum of \$343,666.00 from funds previously appropriated to the following accounts:
